### 1. Call to Order

## 3. Discussion for Consideration, Speakers Marco LiMandri and Jeffrey Lambert:

The City Manager is setting up a task force to look at the downtown management corporation and encourages board members of the ODMD to give their input. The Mayor would like to see a lot more things happen in the downtown. In response to that, we think the best way is by creating a group between the City Manager's office and the existing ODMD to make up this task force. There is no set date for the first meeting but the items for discussion would be:

- Explain in writing the reason for a new district management corporation based upon a 501c3 charitable non-profit
- Consider an RFP for Cleaning Services
- Consider an RFP for Marketing & Promotion
- Consider an RFP for Administration Services
- Consider an attraction of new Board members to speed activities

We are looking at options to see if what is already in place is working or if we can do better. We believe we can generate more money to the association for downtown with a 501c3 that is not currently part of your foundation. The city is not trying to taking over, by coming to your board today we are asking for you to join us in creating a new structure and management organization for downtown that moves forward and is successful.

**Recharte-** The Oxnard Tourism group has launched a social media video of Oxnard which highlights some of the businesses in downtown reminding the community that businesses are open and ready to serve. Looking forward for the banners to be up to add to the reopening efforts.

**Behrens**- This will be an interesting year and we should look for allies. The PAC is under new management and is interested to see what direction they will go. Would like to stay on top of the city to make sure they turn this situation around. All fun events cancelled for this year and would like to work to keep the downtown alive despite that.
